5:00 pm-5:45 pm: The Hidden Dimensions of Poverty: presentation of research approach and results

The Merging of Knowledge methodology used in The Hidden Dimensions of Poverty research involves bringing researchers, policy makers, business leaders, social workers, and teachers together with people who have a lived experience of poverty. Merging of Knowledge is based on ATD Fourth World's philosophy of action, which takes into account the knowledge, experience, and commitment of people living in poverty. Using the Merging of Knowledge methodology allowed this research project to arrive at a multidimensional understanding of poverty, articulating the economic, social, institutional, cultural, and psychological dimensions of poverty. This introductory session will present the methodological principles and summarize the results.

One reason ATD conducted this unprecedented research was that traditional indicators used to measure poverty are inadequate tools for public policy around poverty reduction. By adding new dimensions to the definition of poverty, we radically change the way it is understood. This improved understanding can lead to new policy tools, including better indicators, for poverty eradication in the fields of education, social services, health, etc.

This second session will bring together those in the aid sector to discuss how and under what conditions ATD Fourth World, its partners, and others can use The Hidden Dimensions of Poverty research results to fight poverty and reduce inequalities.
