


All Together in Dignity ATD Fourth World Ireland Annual Report 2023

Vision and mission Statement


OUR VISION is of a world without persistent poverty, where everyone is valued, can participate fully in society and fulfil their potential.

Strategic Goals 2023-2027

These four strategic goals have been informed by critical issues arising from consultations with different stakeholders, and in particular with people with lived experience of poverty, discrimination and inequality who engage with ATD Ireland's mission and work.

These goals were approved by the directors at the board meeting and the draft goals were on display and discussed with members over a number of weeks prior to the AGM.

Goal 1: The ATD Community in Ireland will have an ever-deeper engagement with people living in persistent poverty in which, together, relationships of mutual respect and trust are built; knowledge, experience and learning are shared; and commitments and actions to tackle poverty and social exclusion are jointly agreed and carried out.



Goal 4: ATD Ireland will develop its fundraising capacity and a donor base




Family Visits and Family Support


An integral part of the work done at ATD Ireland are the family visits, cultural outings and family support.

Visits to family homes, hostels and disadvantaged areas take place weekly for a catch up and a chance to discuss some personal issues and offer support if needs be.

There are multiple aims of support; to offer company, to help our members get through times of crisis, to offer support in enabling people to pursue their goals and aspirations and to help people develop their skills, confidence and knowledge. Family support can also include providing character references, accompanying families to court or acting as a liaison with social workers. Family visits can also be an opportunity to invite people to participant in upcoming events and give them the opportunity to meet others with similar experiences.

"There's nothing forced, we don't force ourselves upon them. You're trying to build a bond and a friendship. You don't want to push people away or frighten them off, rather just walking alongside people and to support and just be there. If they want to talk, they want to talk, if they don't, they don't." - Paul.









Keep Connected

We have weekly open house days every Tuesday, where families come to the office and we take part in different creative or knowledge building activities each week. We have lunch together and there is a new chef in the kitchen every week. Activities include regular singing sessions led by Maurice, cooking and baking, art, writing and during the summer we had several fitness sessions led by Paul. We also organised several family outings in 2023. This included bowling and scenic walks to the beach in Dun Laoghaire.

#Addthe10th Campaign

ATD Ireland are part of an alliance called #addthe10th. The purpose of this group is to have socio- economic status recognized as the tenth ground of discrimination in Irish equality legislation, namely the Equal Status Act and the Employment Equality Act.

Hundreds of people across the world have so far taken part in the #Addthe10th campaign.


We have brought the campaign to the United Nations, the EU and to Leinster House.

In 2021 the #Addthe10th alliance submitted a collective response to the government consultation for the review of the equality acts.

On Wednesday 22nd of February, the #Addthe10th alliance was kindly invited by Sinn Féin's TD Chris Andrews and Independent TD Violet-Anne Wynne to attend the debate about the Equality (Miscellaneous Provisions) Bill 2021 — Second Stage in Private Members' Business. Unfortunately the bill was not passed on this occasion.

However, in July Minister Roderic O Gorman published a report on the review of the equality acts.

Amendments to the equality legislation including the addition socioeconomic status as a tenth ground are back on government agenda for Spring 2024 and we will keep campaigining until it happens.






Breaking Barriers- Report on socio- economic discrimination

In October we launched our new report on socio- economic discrimination; "Breaking Barriers: A Participatory approach to Defining Socio- Economic discrimination- In real terms". This report brings together the voices of those with lived experiences of discrimination, academics and professionals working in the community and voluntary sector to break down the term socio- economic discrimination into understandable terms. It also documents three years of campaign work in Ireland and internationally with the #addthe10th campaign to have socio- economic status recognised as the tenth ground of discrimination in Irish equality legislation.


"People treating us differently because of how we look, how we speak, where we live and our wealth...it is hurtful, toxic and it impacts our quality of life".

#Addthe10th at the European Union

On February 22nd ATD teams from ATD Europe including ATD Ireland Community Activist Lorraine met with the EU Fundamental Rights Agency in Vienna to discuss institutional maltreatment and socio- economic discrimination.


"People especially young people with a history of past drug use and trauma are mostly treated unfairly. They don't want to look into the trauma, they just look into the addiction. I personally feel like I've been labelled and there is nothing I can do about it. I feel it will always follow me, and many others feel the same. This makes us feel hopeless."

On Wednesday June 28th, ATD Ireland community activists Andrew and Christina took part in a webinar 'Building an Inclusive Europe: Combatting socio- economic discrimination' organised by ATD Fourth World Europe with the support of the Parliamentary Intergroup on Fighting against Poverty.

"I want a protected law in place because I have this fear that if this law isn't in place my kids will grow up with the fear of not being able to chase their dreams say they want a certain job but they can't get it because of where they're from, what type of life would that be?"

"Changing the law on discrimination is important because people should be treated the same with no high class or low class. What I mean in general is we should be treated with respect."

Youth Event at the Council of Europe

In line with our 2023- 2027 strategic goals, ATD Ireland continued to make efforts to reach out to young people affected by poverty and discrimination.

As a result, we took part in ATD Youth Europe's 2023 youth campaign including a youth study session at the European Youth Centre at the Council of Europe in Strasbourg. This coincided with the 30th anniversary of a major youth meeting at the Council of Europe. The week itself revolved around a series of working sessions in small groups as well as workshops and some fun time to explore the beautiful city and get to know the other young people through games, music, food and conversation. There were 60 young people from 8 different European countries in attendance. The three themes that were focused on were Discrimination and Harassment, Isolation and Choice. The Irish delegation were part of the group on the former. The main focus of the study session was on the last day, when after a week long of hard work and dedicated preparation, the young people from the 3 campaign groups were able to present their collaborative work to important MEPs and officials/representatives from the European institutions.


Christina speaks at a European Parliament Conference on Minimum Income

On 25th October 2023, ATD Ireland community activist Christina presented at Social Platform's annual conference; 'Over the poverty line: The case for adequate minimum income for all'. For several weeks we prepared in the ATD Ireland office through discussions on the topic of minimum income with ATD Ireland community activists and Sister Bernadette who founded the MESL work.

The conference was in aid of the Social Platform 'Over the Line' campaign. Social Platform (of which ATD Fourth World are an associate member) are calling for an EU Directive on Minimum Income. There has been some EU developments on this issue including the proposed council recommendation in accordance with the European Pillar of Social Rights and the European Parliament's Resolution on adequate minimum income. This event was co- hosted by MEP Estrella Dura of The Progressives and Sara Matthieu of Greens/ EFA.

"A minimum income should be an income which meets the cost of living. Social welfare in Ireland does not currently guarantee a minimum income which is above the poverty line and I will talk more about why this is today"







Poverty Aware Practice



ATD Ireland have developed a 'Poverty Aware Practice' module. This module is based on the Hidden Dimensions of Poverty international research and is led by ATD community activists with lived experience of poverty and socio – economic discrimination. The module is comprised of testimonies based on lived experience, group exercises, a presentation and an interactive discussion and Q&A with the class.

The purpose of this module is to enable social work students to have a better understanding of poverty and promote a dialogue between those who have experience of social work intervention and the future social workers.

This year we continued to deliver and develop our poverty aware practice. We presented the module at Trinity and for the first time in Galway University.

Thank you so much to the community activists for leading these sessions and to the students and professors involved.

We also presented the module at the Family Resource Centre National Conference in Tullamore

Poverty Talks

In 2023 Dr Joe Whelan from Trinity College Dublin collaborated with ATD Ireland on a research project "Walking, thinking, and talking An exploration of the lived experiences and hidden geographies of poverty using walking as a participatory arts methodology". Community Activists Andrew, Lorraine, Paul, Kye, Gavin, Ann Marie, Christina, Jimmy, Philip, Long and Terence took part in this research which involved discussing their insights into the experience of poverty while taking a walk through an area of importance to them This project culminated in an animated film, research report and website.

The project including research report and film was launched on October 6th at IHREC offices with MC Father Peter McVerry.





"Academics + Community Activists = New Knowledge and solutions"

17th October

On Tuesday the 17th Of October ATD Ireland and the 17th October Committee had our annual commemoration for the UN Day for the Eradication of Poverty at the Human Rights and Poverty Stone on the Custom House Quay in Dublin. The theme this year was "Let Dignity Be Our Compass: Working Together Towards Change". This theme and visual was collectively decided by the 17th October Committee. The four axis of the compass points to four issues of critical importance for Irish society in order to achieve the full realisation of human rights, equality and social justice. These include "Zero discrimination, Affordable accommodation, A minimum standard of income and Dignified work and opportunities to participate".

The MC for this year was Professor Mary Murphy from Maynooth University and later Brian O Toole. We were very pleased to have Minister of State for Community Development and charities Joe O Brien attend and speak at the 17th October event this year. Wonderful music was provided by the choirs from St. Mary's secondary school, Holy Faith, Glasnevin and St Laurence O'Toole CBS and St Laurence O'Toole National School.

Leave No One Behind Series 3


Leave No One Behind Series 3 is a workshop series designed to start an inclusive conversation about the 2030 Agenda's Leave No One Behind Promise. It aimed to raise awareness of the Leave No One Behind Promise of the UN 2030 Agenda for Sustainable Development and to involve citizens from all walks of life (children, youths, adults-including people with experience of poverty and marginalisation). We want to empower marginalised groups to actively contribute to dialogue in Ireland around the Sustainable Development Goals by valuing their knowledge of social exclusion issues based on lived experience.

Series 3 was designed to focus on highlighting positive actions taking place around the country which aim to improve the health and wellbeing in local communities –putting these goals into practice.

This project began after identifying a diverse range of community groups specifically working with people who are often left behind. The groups included those working with people from a variety of life experiences including; Families in Direct Provision, Traveller groups, Recovery groups, Young People, Asylum seekers, people with experience of prison, Adults struggling with literacy, people living in isolated rural areas, those struggling with poor mental health and people with experience of poverty. Using art and other creative methods we identified important actions which can help ensure that no one is left behind.

In July 2023, we launched the project and showcased the beautiful artwork at an uplifting community event at Mud Island Community Gardens. The project participants gathered and conversed together with music and refreshments.










Pathways to Participation

Following on from the success of our <u>"Lockdown Liberties: Spoken and written word"</u> project, ATD Ireland are proud to launch a new creative writing project **"Creative Pathways to Participation"** funded by Coalition 2030.

The aim of this project is to nourish and spotlight the creative talents and knowledge of those impacted by poverty and discrimination or those who otherwise experience marginalisation. It hopes to give people an avenue to share their lived experience, insights and perspectives on topics which are important to them. This project is about recognising the value of creative outlets in people finding their voice and self- expression, given that people who are struggling are not often given the platform to do so. Finding one's voice can lead to all manners of civic participation and involvement.

This project hopes to raise awareness of the Sustainable Development Goals through the lived experience of social exclusion.




